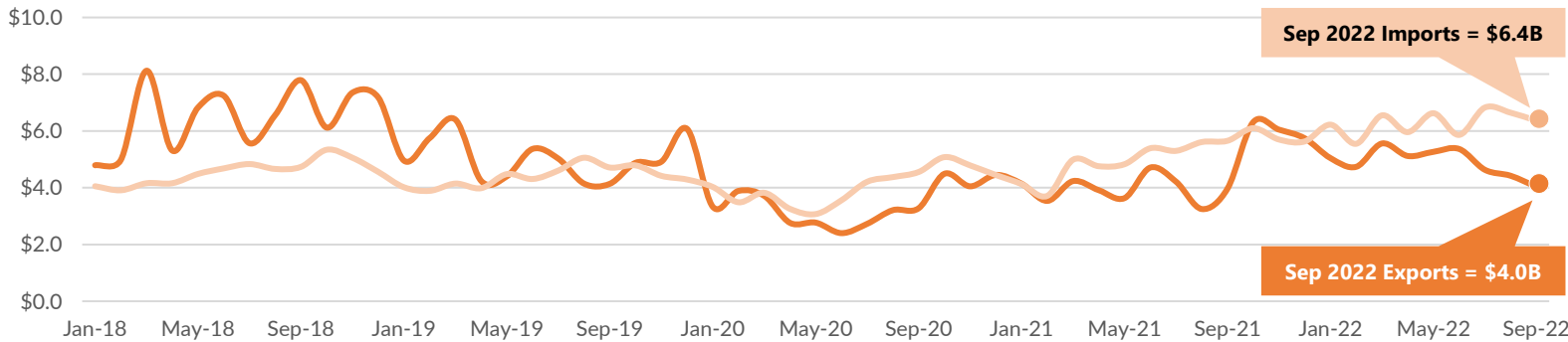


In the third quarter of 2022:

- **Exports Continue Recovery:** Businesses in WA exported \$13.1 billion of goods in Q3—a decrease relative to Q2 (-17%) but still in line with the upward trajectory established post-COVID (+15%).
- **Imports Remain Elevated:** WA imports totaled \$19.8 billion of goods in Q3—a slight bump (8%) from Q2 and 19% above Q3 2021 levels, maintaining a streak of post-COVID highs that began in early 2022.
- **Trade Volume Steady:** WA ports transported about \$46 billion in goods in Q3—while this is a slight decrease from Q2 (-3%), trade volume has been consistent since late 2021.

Total Monthly Goods Exports & Imports

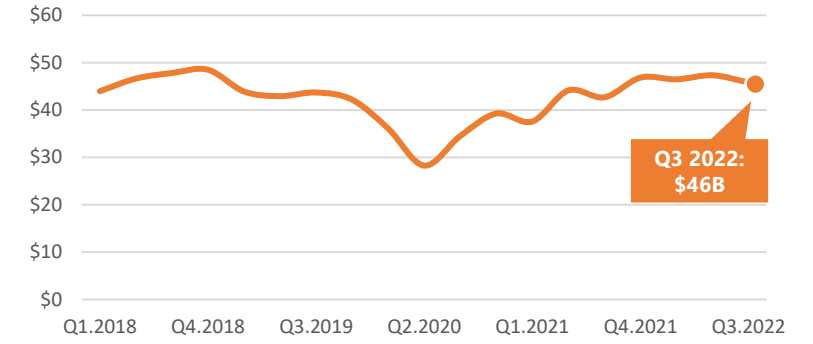
Billion \$; Jan 2018 – Sep 2022

Billion \$; Q1 2018 – Q3 2022

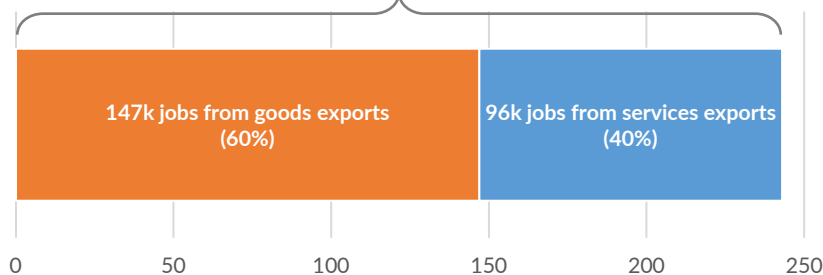

1,000s of jobs; As of 2020

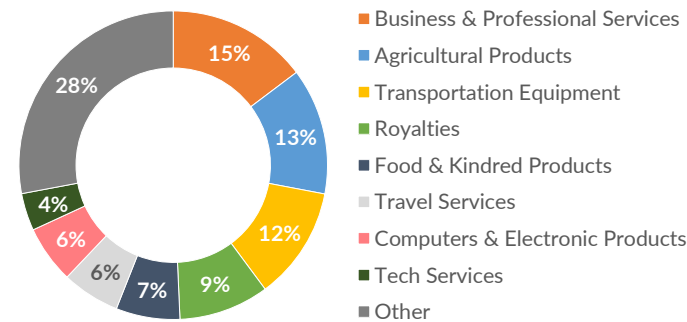
Total Jobs Supported by Exports = 243k
